**Gen Ronald R. Fogleman** (USAFA; MA, Duke University) is chief of staff of the United States Air Force. A command pilot with more than 6,300 hours, General Fogleman has commanded an Air Force wing and air division, directed Air Force programs on the Air Staff, and served as commander of the Seventh Air Force of Pacific Air Forces with the added responsibility as deputy commander of US Forces Korea and commander of Korean and US air components assigned under the Combined Forces Command. Prior to becoming chief of staff, he was commander in chief of the US Transportation Command and commander of the Air Force's Air Mobility Command. General Fogleman is a graduate of the Army War College.



**William M. Arkin** (BS, University of Maryland) is an independent writer and consultant. He was military adviser to the International Study Team (the so-called Harvard Study Team) and spent seven weeks in postwar Iraq during 1991 and 1993 inspecting over 350 bombed sites and interviewing Iraqi officials, soldiers, technicians, and civilians. He has lectured widely on his observations of postwar Iraq. He received support from the John D. and Catherine T. MacArthur Foundation in 1995 to study the bombing of electrical systems in warfare and visited Lebanon in 1996 as a consultant to Human Rights Watch to inspect Israeli attacks. He continues to work on a book—Target Iraq—about the true effect of the air war. Arkin, an Army intelligence analyst from 1974 to 1978, is the

author or coauthor of nine books on military matters, including the prestigious Nuclear Weapons Databook series. His latest is *The US Military Online: A Directory for Internet Access to the Department of Defense*. He is a columnist for *The Bulletin of the Atomic Scientists*.



**Dr. Joel S. A. Hayward** (MA, PhD, University of Canterbury, Christchurch) is a lecturer in the Department of History, Massey University, Palmerston North, New Zealand. In 1994, the USAF Historical Research Agency awarded him a research scholarship to conduct archival research for his doctoral dissertation on German air operations during Hitler's eastern campaign of 1942-1943. After conducting extensive research at the agency, he received a research fellowship from the German government to enable him to conduct research in the German Military Archives in Freiburg, Germany.



**Col Charles R. Myers** (BA, Tulane University; MA, PhD, University of Texas at Austin; JD, University of California, Berkeley) is professor and head of the Department of Philosophy and Fine Arts, US Air Force Academy. He began his Air Force service as an intelligence

officer, including an assignment at Da Nang AB, Vietnam. After teaching philosophy at the Air Force Academy, he attended law school under the Funded Legal Education Program. His duties as a judge advocate have included assignments at wing, numbered air force, and major command levels in several commands and at the Air Force Legal Services Center. His most recent assignments were as the staff judge advocate for Seventh Air Force and for United States Strategic Command. He assumed his present position in January 1995. He is a graduate of the National War College.



**Lt Col Rhonda Cornum** (BS and PhD, Cornell University; MD, Uniformed Services University) is a urologic surgery resident at Brook Army Medical Center, San Antonio, Texas. She was an operational flight surgeon with the 2/229 Attack Helicopter Battalion during Operations Desert Shield and Desert Storm, and a staff scientist in the Crew Life Support Branch at the US Army Aeromedical Research Laboratory, Fort Rucker, Alabama. Her research interests include factors affecting success in aviation training, integration of advanced visual displays, and transfusion therapy in shock and trauma. Colonel Cornum is a graduate of Air Command and Staff College.





**Dr. John Caldwell** (BS, Troy State University; MS, University of South Alabama; PhD, University of Southern Mississippi) is an experimental psychologist in the Aircrew Health and Performance Division of the US Army Aeromedical Research Laboratory, Fort Rucker, Alabama. For the past 10 years, he has been conducting laboratory, simulator, and in-flight research into the effects of pharmacological compounds, stress, and fatigue on the performance of military aviators.



**Lt Col Kory Cornum** (USAFA; MD, Uniformed Services University) is currently an orthopaedic surgery resident at Wilford Hall Medical Center, San Antonio, Texas. He was the flight surgeon for the 33d Fighter Wing during Operations Just Cause, Desert Shield, and Desert Storm, and during multiple overseas deployments. Subsequently, he served as a staff scientist at the Armstrong Laboratory at Brooks AFB, Texas. His research interests include effects of fatigue, circadian dysrhythmias, and pharmacological compounds on pilot performance. Colonel Cornum is a graduate of Squadron Officer School.



**Gen Charles C. Krulak** (BS, US Naval Academy; MS, George Washington University) is commandant of the United States Marine Corps. He has held a variety of command and staff positions during his career, serving as commander of Marine Forces Pacific/ commanding general of Fleet Marine Forces Pacific, Camp H. M. Smith, Hawaii, immediately prior to assuming duties as commandant on 30 June 1995. General Krulak is a graduate of the Amphibious Warfare School, Army Command and General Staff College, and National War College.



**Lt Col Wray R. Johnson** (BA, Southwest Texas State University; MS, Troy State University in Montgomery; PhD, Florida State University) is the senior defense advisor to the director of the United States Information Agency in Washington, D. C. Prior to that assignment he was chief, Foreign Internal Defense, Headquarters Air Force Special Operations Command, Hurlburt Field, Florida. In that capacity he was instrumental in the conception, design, and fielding of the 6th Special Operations Squadron, the first-ever USAF squadron dedicated to the foreign internal defense and combat advisory mission areas. Previous assignments include service in the Air Force Office of Antiterrorism at the Pentagon and on the faculty of the USAF Special Operations School at Hurlburt. He continues to lecture widely on revolutionary warfare, counterinsurgency, psychological operations, and intercultural communications in limited and unconventional warfare.

**Dr. James J. Wirtz** (BA, MA, University of Delaware; MPhil, PhD, Columbia University) is associate professor of national security affairs, Naval Postgraduate School, Monterey, California. He was a John M. Olin Fellow at the Center for International Affairs, Harvard University, and his work on the subject of national security has been published in a number of journals. Professor Wirtz is the author of *The Tet Offensive: Intelligence Failure in War* and coauthor of a forthcoming book entitled *The Absolute Weapon Revisited: Nuclear Arms and the Emerging International Order*.



**Dr. Ronald J. Kurth** (BS, US Naval Academy; MPA and PhD, Harvard University) is dean of academic affairs at the Air War College, Maxwell AFB, Alabama. He served in the US Navy for 36 years—as a flag officer during the last 10 years of his career. He received the Defense Distinguished Service Medal, the Navy Distinguished Service Medal, and three awards of the Legion of Merit. Dr. Kurth was president of the Naval War College, Newport, Rhode Island, from 1987 to 1990, and of Murray State University, Murray, Kentucky, from 1990 to 1994.

**Capt George Conner** (BS, Montana State University; MS, Naval Postgraduate School) is assistant provost and a senior lecturer at the Naval Postgraduate School, Monterey, California. Prior to his retirement in 1994, he held the Chair for Tactical Analysis and served as dean of military faculty at the Naval Postgraduate School. He also served as special assistant for program objective memorandum and budget to the assistant secretary of the Navy (manpower and reserve affairs) and as acting deputy assistant secretary of the Navy (manpower) during the mobilization of armed forces for Operation Desert Storm. Captain Conner's decorations include the Legion of Merit, Meritorious Service Medal, and Navy Achievement Medal.

**Lt Comdr Angus McColl** (USNA; MS, Naval Postgraduate School) is the executive officer of the Blue Crew on the USS Ohio (SSBN-726), homeported at Bangor, Washington. His prior experience is in attack submarines, nuclear-propulsion maintenance, and carrier battle group operations.
